GRAFTON COUNTY COMMISSIONERS' MEETING Administration Building North Haverhill, NH 03774 August 1, 2023

PRESENT: Commissioners Piper, Ahern and McLeod, County Administrator Libby, Assistant County Administrator Burbank, Administrative Assistant Norcross

Commissioner Piper called the meeting to order at 9:00 AM began with the Pledge of Allegiance.

HR Director Clough arrived and gave the following report: (* see attached)

HR Director Clough reviewed information with the Commissioners for their upcoming DoC Superintendent interviews.

Nursing Home Administrator Labore arrived and gave the following report: (* see attached)

- 1. Contract Nursing Utilization Update NHA Labore thanked the Commissioners for their support with the targeted wage increase for nursing staff, noting that it appears they have found a sweet spot with recruitment and they have many happy employees. Since July, the Nursing Home has not renewed six (6) contracted LNA assignments and have another two (2) set to expire this week as well. NHA Labore added that he anticipates that mid-October November they will have eight (8) new LNAs that will be finishing the class. He stated that the response to these wage increases has been better than he anticipated.
- 2. DHHS RFP County Pilot to Delay or Defer Institutional Care NHA Labore reported that his personal opinion regarding this idea is that this is what was talked about in 2018 when Medicaid Managed Care was being discussed. This RFP is talking about Programs for All Inclusive Care for the Elderly (PACE Programs). He stated that other Nursing Home Administrators and County Administrators were unaware that this RFP was coming. NHA Labore explained to the Commissioners that there is no way to put a meaningful response back to this RFP within 30 days and therefore he would not recommend any investment in his time to go forward with this. He stated that it is a shame because this is a wasted opportunity. If they had more time, they could have done something with it.
