Why Broadband

Lebanon, VA – Pop 3,206

 In Lebanon, Virginia, defense contractor Northrup Grumman and IT consultant CGI announced the creation of 700 jobs paying twice the median wage.

Dawsonville, GA – Pop 2,882

 A new data center in Dawsonville, Georgia, created 12 high-paying jobs and expanded the local tax base thanks to the municipally-owned North Georgia Network.

Gibbon, MN – Pop 749

In the small Minnesota town of Gibbon, the fiber network from the RS Fiber Cooperative
convinced the owner of Advocate 3D to take up residence in town where the family could live
the small-town life but the business could still obtain the high-speed, reliable connectivity
they needed for their 3D printing business.

Princeton, IL – Pop 7,603

 When the city of Princeton, Illinois set up a municipal broadband network, it kept 300 jobs in the community with the global industrial machinery company, Ingersoll Rand.

Newport, WA – Pop 2,071

 IT company Exbabylon LLC expands and recruits talent in Newport, Washington because of Pend Oreille County PUD's fiber network.



FY22 REQUESTS:

- 1. 2022 Budget Request \$50,000

- Grants: Writing and Management
- 2. Match from Rescue Plan \$ (along with SB 85 \$) \$ TBA
- 3. Authorization to Pursue Grants and Accept Unanticipated Revenues



Funding Opportunities

American Rescue Plan Act:

- \$457 million for counties and municipalities, \$122 million for critical capital projects, \$350 million for schools.
- \$457 million: broadband construction specifically called out. Availability soon.
- \$122 million: broadband may be eligible.

Omnibus Budget Bill (Dec. 2020)

- \$250 Million for Additional FCC Support for Telehealth
- \$300 Million to Promote Broadband Expansion to Unserved Americans
- \$65 Million for Better Broadband Maps

Funding Opportunities

Northern Border Regional Commission:

 Best opportunity for economic development.
 Received \$5m more than usual. Make connections to Opportunity Zones. Can match other federal funds!
 Deadline May 14.

US Economic Development Administration

 Another good opportunity for economic development. \$200m available. Rolling deadline.

NH SB 85:

 State grants for planning and construction for projects at 50/50% - Availability and deadline unknown.
