## Request for Proposals – Dry Haying Services

The Grafton County Commissioners are soliciting bids from qualified contractors for the dry haying of approximately 50 acres of farmland located in Grafton County. We aim to maintain approximately 4000 square bales with the option of round bales as well. The selected vendor will be responsible for providing start to finish baling services on a per-acre pricing basis. Bids should be submitted in accordance with the following specifications:

### 1. Scope of Work:

- **Haying Services:** The vendor will be responsible for performing dry haying services on approximately 50 acres of farmland. This includes cutting, raking, baling, and stacking hay.
- **Bale Quantity and Types:** The vendor should be capable of producing approximately 4000 square bales with the option of round bales as well.
- **Equipment and Staffing:** The vendor must possess the necessary equipment and staffing to efficiently execute the haying process from start to finish. This includes mowers, rakes, balers, and stacking equipment.
- **Quality Assurance:** The vendor should ensure that the hay produced meets acceptable quality standards, including proper moisture content.
