At GCNH we accomplish this goal by caring for our residents as we would for one of our own family members because we view each of our residents as a member of our extended family. We are committed to providing preventative and restorative care for all residents, and we will attempt to provide a safe, comfortable, home-like atmosphere.

At GCNH, we foster a resident-centered approach focusing on each resident's individual emotional needs and care preferences, consistent with their lifestyle.
